Noble submitted a form 17 Bradenhead Pressure test that meets the case 5 criteria, Doc #402038976. Noble took a fluid sample and the lab results shows the oil sample doesn't match the Niobrara oil API in this area. This well was drilled with an oil based mud. We would like to do an another fluid pull on surface casing and try to capture a sample. And run it through lab again for results. We will communicate it to COGCC through Form 4 with our mitigation plan based on new results.
