 Surface Casing: 8-5/8", 24#, 207' (5 joints), set at 217' KB, cemented with 130 sacks.
 Plugged: December 8, 1990
 Procedure: A surface pipe plug was used with 5 sacks at the top and 35 sacks on the bottom of the surface casing. A cement plug of 30 sacks of cement was placed from 4905' to 4995'. The top of the surface casing was cut off and a steel cap was welded on. Permission to plug was granted by Mr. Stotwell of the Colorado Oil and Gas Commission.
