Comment: Stormwater erosion is occurring in several areas along the access road. Stormwater controls that are in place are largely not adequate or properly installed. Cut banks along access are not stabilized and are eroding. See attached photos.

Corrective Action: Stormwater controls need to be installed along the access using good engineering practices such as those described in CDOT manuals for erosion and stormwater control. Erosion along the access road needs to be stabilized.
