- 2-13-52 Perforated 4885-86 with 4, 10 gram jets. Tested for water. No water recovered.
- 2-14-52 Perforated 4870-85 with 60, 10 gram jets. Ran 2" tubing.
- 2-15-52 Swabbed 20 bbls. load oil, 92 bbls. new oil, no water, 19 hours. Waiting on rods.
- 3-17-52 Pumped 91 bbls. oil, no water, 24 hours. COMPLETE
