Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be completed no later than 3/1/2019.

COGCC required a surface owner letter regarding the Oil and Gas tanks. The COGCC has provided Operator multiple notices regarding this requirement, no documentation has been provided.

Cement base requires removal and can only be buried with only with the prior written consent of the surface owner in accordance with 1004.a. No documentation showing prior consent has been provided.

Operator has not provided documentation that weed management has been conducted.

Location remains out of compliance with COGCC 1000 series reclamation rules. Original corrective action and date remains applicable.
