The Jurisdictional Agency determination was based on information contained in or added to the Application. Review by the professional staff of the Colorado Commission indicates that this well is an (New) (~~Old~~) well. The well produces from the Mancos "B"

reservoir(s); and was drilled after February 19, 1977. No marker well is located within a radius of 2.5 miles.

This conclusion was originated by examination of plat records maintained by the Colorado Commission, completion report, statements and attachments to the application.

Which show this well is a new onshore well not located within 2.5 miles of a marker well.
