While there, I observed (A Production Operation.) During this inspection compliance issues were observed: Unused equipment stored on location. (cattle panels on the ground and stored on location) Stormwater erosion not being controlled on the location at this time. Erosion is evident along un-stabilized slope at the SW side of location.
