COMMENTS:

Due to further review of offset data finding a shallow "boulder zone" it is necessary to deepen the conductor from 60' to 275'. This 20" conductor will be drilled down with Layne's (a granite company) casing advance system that under cuts a 22" hole while pushing down the 20" welded casing. The 20" casing will be cemented to surface with construction grade cement. To facilitate the 20" deepening an additional 30" conductor will be set in a augered 36" hole to 40'. Cemented to surface with construction grade cement.
