The Tudex Plugging and Flow line Abandonment Project is underway. The Hi Land 10B and Hi Land 10G are (2) of the wells on the project to be plugged and abandoned. This is a site visit in preparation for moving rig onto the well location. Currently the location consisted of (2) wellheads, (6) anchors and chain link wellhead fencing. No issues were noted at time of inspection that would prevent rig and equipment from staging and performing plugging task.
