Pit is 8'W x 8'L x 11'D. All 4 interior walls are lined with wood boards, 2" x 12" x 8'. The pit bottom is open. The sampling plan is to bore holes thru the wall boards, holes will be at random depths below grade, and collect two samples from each wall for a 4 wall composite of eight samples. An additional composite sample will be taken from the bottom of the pit. The 4 wall composite sample and the pit bottom composite sample will each be analyzed for SAR, BTEX and TPH.
