Annual weeds such as Russian thistles will require management such as mowing or chemical treatment if they grow large enough to flower or break of and become debris. It is not apparent whether the Russian thistle seedlings on the well pad at this time may be stunted from historic treatment. This needs to be monitored and controlled as needed.
