On July 11, 2019, COGCC Environmental Staff (John Heil and Steven Arauza) conducted an environmental field inspection of TEP ROCKY MOUNTAIN LLC (TEP operator #96850) Location ID 426533.

COGCC staff inspected the tank battery, separator and wells on location. COGCC staff observed a heated horizontal separator located approximately 15 feet north of a 400 BBL Condensate tank. COGCC staff also observed fluids within the secondary containment of the tank battery, no sheen or odor was observed (See photos).
