#### COMMENTS:

Bonanza Creek respectfully requests continued TA status. The Antelope 22-18 was plugged back with CIBP @ 6182' with 2 sacks of cement on 4/9/2019. Form 5A to report TA status of Nio/Codell was submitted 5/6/2019 (Doc #402025068); the well was SI and plugged back due to offset HZ frac of Bonanza Creek's Antelope T-19 Pad. The well is closed to the atmosphere via valve locked out and tagged out at the master valve, and the a "Temporary SI for HZ prep" sign is attached to the master valve. Pressure test was performed 4/9/2019 well pressure tested 1000 psi, held pressure for 10 minutes, test was good. This well is being evaluated as a potential gas injection well for a future Bonanza Creek gas injection project, therefore are requesting continued TA status until such time. An annual TA sundry will be submitted in 2020 to update the COGCC of this well's status.
