NFPA placard appears to have been peeled off a produced water tank. Needs to be replaced. INSTALL SIGN TO COMPLY WITH RULE 210.D. (Corrective Action Date: August 24, 2019) See attached photo #3.</li> <li>2. Unused riser near other ECDs. COMPLY WITH RULE 603.F. (Corrective Action Date: August 24, 2019) See attached photo #4.</li> <li>3. Trash near west separators in berm. COMPLY WITH RULE 603.F.
