Cracking in berms needs to be monitored and stabilization measures employed if cracks deepen or slipping occurs. Stormwater controls need to be installed using good engineering practices such as those described in CDOT manuals for stormwater and erosion control.

The northwestern project area has been stabilized with additional erosion control measures. Monitoring of the cracking in the berm continues, however the cracks have been fixed. Due to this effort, more seeding is required. The cutslope and this berm area are scheduled for seeding and hydromulch.
