Comment: Approximately 500 musk thistle in flowering and basal condition, and 100 Russian knapweeds identified within the project area. A germination transect was conducted and identified successful revegetation in some plots, and little to no revegetation in others. Significant cover of competing weed species present. Weeds recently mowed in a portion of the project area, but no entire project area. Revegetation needs to be carefully monitored and weeds controlled until desirable cover is established.

Corrective Action:	Control weeds. Musk thistles in flowering condition need to be cut, bagged, and properly disposed of no later than August 2, 2019, to prevent seed dispersal. Thistle rosettes and other weeds (ie R. knapweed) need to be controlled by August 23, 2019.	Date	08/02/2019
