To allow time for operator to 1) Collaborate with the surface owner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities, or crop production, and 2) to allow operator time to perform any needed tests to determine the issues on location that are hindering reclamation, all reclamation activities will be conducted by 11/31/2019
