South end of berm is in disrepair, contains holes. REPAIR OR INSTALL BERMS OR OTHER SECONDARY CONTAINMENT DEVICES PER RULE 605.A.(4) (Corrective Action Date: August 30, 2019) See attached photos #11,12.</p> <p>2. Stained soil at well (front and back), and in two separator houses. SECURELY FASTEN ALL VALVES, FITTINGS, AND PIPES TO ENSURE GOOD MECHANICAL CONDITION, INSPECT AT REGULAR INTERVALS AND MAINTAIN IN GOOD MECHANICAL CONDITIONS PER RULE 605.D.
