On July 26, 2019, COGCC Environmental Staff (John Heil and Steven Arauza) conducted an environmental field inspection of CAERUS PICEANCE LLC (Caerus operator #10456) 697-21A-66S97W Location ID 335476. Weather was sunny and temperatures about 70 degrees Fahrenheit.

Upon inspection, the operator's staff was backfilling the excavation from Spill ID 465066 (See photos).

COGCC staff observed a 3 feet by 4 feet by 6 feet deep excavation and a 1.5 feet by 4 feet by 6 feet deep excavation located southwest of heated horizontal separators (See photos).
