COMMENTS:

Request to flare is being made as a result of Anadarko shutting down their Third Creek Gathering System which was the gas sales outlet for the Ferguson #3-25. It is estimated that approximately 5 MCFD from the well will be flared using a central tank battery combuster. A trace amount (2 PPM) of hydrogen sulfide was tested in the gas in an Anadarko meter run sample from 12/12/2017 and only 1/4 PPM of hydrogen sulfide was tested from a sample collected 7/9/2019. Those gas analysis have been attached.

This flaring request is made necessary by the shutting down of the Anadarko Third Creek Gathering System. The Ferguson #3-25 was making approximately 1 1/2 BOPD and 5 MCFD when the shut down took place. Oil revenue dominates the economics of this well. At this point of the gathering system shut down no clear economic alternative to reestablish beneficial gas deposition and the length of this request to flare is undetermined. Conditions of approvals listed in a COGCC Stuart Ellsworth email from 9/19/2018 will be adhered to.
