On 7-29-2019 at approximately 15:00, inspector Rick Moran, conducted a routine inspection at Genesis Gas & Oil Colorado well Calamity Ridge 14-15C-1N100 in Rio Blanco county.

During this inspection the following compliance issues were observed:

- 1) Weeds. Photos 2 & 3. Complete by 8-23-2019.
- 2) Soil staining around well head. Photo 4. Complete by 8-30-2019.
- 3) Casing valve gas leak. Photo 5. Complete by 8-6-2019. - Resolved.
- 4) Tank without label. Photo 6. Complete by 9-30-2019.
- 5) Missing bird protection on tank stack. Photo 7. Complete by 8-30-2019.
- 6) Stormwater control. Photo 8. Complete by 8-30-2019.
- 7) Missing "911" on battery sign. Photo 9. Complete by 9-30-2019.
- 8) Culvert trash. Photo 10. Complete by 8-30-10.
- 9) Fallen deadman marker. Photo 11. Complete by 8-23-2019.

The inspector called 970-361-3007 at 16:43 on 7-29/2019 to report the casing valve gas leak. A call back occurred at 16:54 stating a person would be dispatched to resolve the issue. Gas leak was found resolved on a follow up inspection on 8-1-2019 at 13:30.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
