	<p>Areas at the location with inadequate vegetation establishment have been interseeded and vegetation is establishing.</p> <p>There is an area (photo 2) where erosion caused additional disturbance extending into the pasture. This area needs to be recontoured to grade and reclaimed/reseeded. This corrective action from the previous inspection has not been completed. Photo 4 shows the erosion that was documented in 2016, which caused the disturbance to the adjacent pasture. See attached photos</p>	
Corrective Action:	<p>Reclaim and stabilize the area (COGCC photo 2) where erosion caused additional disturbance extending into the pasture. Closely monitor the interseeded area and reseed as needed. Location remains out of compliance.</p>	Date: _____

Comment: Rock check dams have been installed up gradient of the culverts and near the double gates shown in photo 6.
 The rock rip/rap at the culverts has been reinstalled to allow sediment to settle and not restrict stormwater flow. Previous inspection did not observe geotextile installed as it was obscured from view at the outlet protection. This inspection shows that there is geotextile installed per good engineering practice. The previous corrective action is completed.

Wattles installed at the location have degraded and need to be removed or replaced.

Corrective Action: Remove or replace all degraded wattles from the location.
