OPERATOR COMMENTS AND SUBMITTAL

Comments

The Windows/Twinning exception location waiver is included in the SUA (Page 4, Sec 6).

The Reveille A34-788 (Form 2 Doc #402092784), proposed by Noble Energy, Inc, is the nearest well in the same formation, the distance was measured in 2D.

The nearest wellbore belonging to another operator was measured to the Howard 04-27 (05-123-13630, PA), operated by Cannon Resources. The distance was measured utilizing the Anti Collision Report attached with Deviated Drill Plan measured in 3D.

No wells owned by other operators are Producing, Temporarily Abandoned, or Shut-In within 150' of this wells productive lateral, therefore stimulation setback consent is not needed.

Noble Energy shall isolate both the Fox Hills and Upper Pierre Aquifers with surface casing from hydrocarbon bearing zones and exposures to oil based drilling fluid. Noble Energy also agrees to not expose the Upper Pierre Aquifer to oil based mud.

1	Drilling/Completion Operations	Bradenhead Monitoring: Noble Energy acknowledges and will comply with COGCC Policy for Braden-head Monitoring during Hydraulic Fracturing Treatments in the Greater Wattenberg Area dated May 29, 2012.
2	Drilling/Completion Operations	Alternative Logging Program: One of the first wells drilled on the pad will be logged with an open-hole resistivity log and gamma-ray, from the kick-off point into the surface casing. All wells on the pad will have a cement bond log (CBL) with gamma-ray run on production casing (or on intermediate casing if production liner is run) into the surface casing. The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log. The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached. The Form 5 for a well without open-hole logs shall clearly state "Alternative Logging Program - No open-hole logs were run" and shall clearly identify the type of log and the well (by API#) in which open-hole logs were run.
3	Drilling/Completion Operations	Anti-collision: Noble Energy will perform an anti-collision evaluation of all active (producing, shut in, or temporarily abandoned) offset wellbores that have the potential of being within 150 feet of a proposed well prior to drilling operations for the proposed well. Notice shall be given to all offset operators prior to drilling.
