Comments	<p>The Windows/Twinning exception location waiver is included in the SUA (Page 4, Sec 6).</p> <p>The Reveille A34-768 (Form 2 Doc #402092802), proposed by Noble Energy, Inc, is the nearest well in the same formation, the distance was measured in 2D.</p> <p>The nearest wellbore belonging to another operator was measured to the Howard A34-03 (05-123-14819, PA), operated by Gerrity Oil. The distance was measured utilizing the Anti Collision Report attached with Deviated Drill Plan measured in 3D.</p> <p>No wells owned by other operators are Producing, Temporarily Abandoned, or Shut-In within 150' of this wells productive lateral, therefore stimulation setback consent is not needed.</p> <p>Noble Energy shall isolate both the Fox Hills and Upper Pierre Aquifers with surface casing from hydrocarbon bearing zones and exposures to oil based drilling fluid. Noble Energy also agrees to not expose the Upper Pierre Aquifer to oil based mud.</p>
