Comment: The road has been graded and vehicle ruts are filled in. Some areas may need to have more gravel to avoid road damage in the near future.
 There were multiple culverts filled in with sediment, causing stormwater to flow across the road causing damage. BMP's need to be installed to prevent erosion from filling in culverts. At one point, water from the ephemeral creek is flowing down the side of the road. See attached photos and GPS coordinates for some issues identified.
