General Comment:

Environmental Inspection performed in response to Complaint #200447840 regarding concerns about public safety due to open excavation adjacent to Tipple Parkway in Frederick related to a flowline release documented by Spill Facility #463820 and Remediation #13446.

Any corrective actions required by previous inspections that were not completed are still required.

Operator had traffic sign, and cones in place at time of inspection. Operator personnel report covering excavation with plywood and securing excavation with construction fence when location is not attended. Operator shall backfill excavation as soon as practicable until a workplan is approved by COGCC for additional delineation and remediation. Operator shall comply with applicable traffic regulations regarding open excavation adjacent to a road. Operator shall coordinate with City of Frederick on all future work and scheduling related to this remediation. Operator shall secure excavation appropriately to prevent unintended entry until backfill is complete. See specific corrective actions and deadlines on following pages.

Comment: Excavation related to Rem #13446 remains open. KPK personnel performing flowline pressure test at time of inspection (reference Insp Doc #690101340). Excavation is located immediately adjacent Tipple Pkwy. Approximate dimensions were 10' x 20' by 8' to 10' deep. Trench box in place at time of inspection. Some standing water observed in bottom of excavation. Traffic sign and cones in place on Tipple Pkwy.

Corrective Action: Submit a Supplemental Form 27 with additional confirmation soil sample results and groundwater results if available. If delineation and remediation is not complete, submit a detailed plan to delineate the lateral & vertical extent of soil impacts and the extent of any groundwater impacts. Approved remediation #13446 completion schedule was 5/10/19. Operator shall include a specific implementation schedule to complete additional delineation and remediation. Backfill excavation until a workplan for additional delineation and remediation (if needed) is approved. Comply with applicable traffic control regulations and coordinate all ongoing and future work with local government.
