**General Comment:****COGCC Inspection Report 689802977 Summary**

On Tuesday 8/13/2019 at approximately 12:20, I, Inspector Emily Waldron, conducted a field inspection at Sandridge Exploration and Production LLC Mutual 01-17H at 324757 in Jackson County Colorado.

While there, I performed a follow up inspection to vehicle tracking issues observed in inspection document number 689802878. Vehicle tracking corrective actions have not been resolved.

During this inspection the following possible compliance issues were observed:

Tracking pad not adequately maintained to prevent track of material offsite. See photos 1-4. Maintain vehicle tracking BMPs on the oil and gas location to comply with rule 1002.f.(2)F. If material is tracked onto County or public roads, contact the appropriate authority by 5/6/2019.

I spoke with Russel Shipley and Spence Laird of Sandridge on 8/14/2019 to discuss addition of tracking measures and to explain that more measures will be needed to return to compliance.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
