Comment: **This location is not in compliance with Rule 1004. Reclamation rules require reclamation activities to be conducted within three months of plugging on cropland. Well was plugged 7/17/2017; therefore, final reclamation activities should have been completed no later than 10/17/2017. Operator has failed to reclaim the access road and remove culverts. Also, disturbance areas are not reflective of reference crop vegetative levels. Refer to the attached inspection photos.**
