NOTICE OF HEARING BEFORE THE OIL AND GAS CONSERVATION COMMISSION OF THE STATE OF COLORADO
CAUSE NO. 397
IN THE MATTER OF THE PROMULGATION AND ESTABLISHMENT OF FIELD RULES TO GOVERN OPERATIONS IN THE MARKS BUTTE FIELD, SEDGWICK COUNTY COLORADO TO ALL PERSONS AND TO WHOM IT MAY CONCERN:

On February 4, 1983, Lyle Johnson, Inc. by its attorney filed with the Commission an application for an order to establish a 320-acre drilling and spacing unit for the production of gas and associated hydrocarbons from the "D" Band underlying the following described lands in Sedgwick County, Colorado, to-wit:
Township 10 North,
Range 47 West, 6th T.M.
Section 25 E4

and further that Well Donaldson 28-1, located 1430 feet from the south line and 1250 feet from the east line of said Section 25 be considered the permitted well for the unit and that all interests in the unit consisting of the E $\frac{1}{4}$ of said section, be pooled for the development and operation of the unit for the production of gas and associated hydrocarbons from the "D" Band according to 34-60-116 C.R.S. 1973, as amended.

NOTICE IS HEREBY GIVEN, that the Oil and Gas Conservation Commission of the State of Colorado, pursuant to the above, has scheduled the above-entitled matter for hearing on:

Any interested party desiring to protest the granting of the application should file with the Commission a written protest no later than March 16, 1983, briefly stating the basis of the protest, and such interested party shall, at the same time, serve or mail a copy of the protest to the person filing the application.
