Other Operator submitted, 3/1/16, a Form 4 (#400998389) reporting Status of Reclamation at site & plans for continuing Reclamation activities. Other Operator, mistakenly thought this was a Historical site of theirs' that needed Final Reclamation for Bond Release. Reclamation activities at site had commenced when Eagle Operating corrected mistake & had Other Operator halt Reclamation activities.

Comment: Location does not meet Final Reclamation requirements. The Location, including the well pad & access road, is not re-contoured, de-compacted, or properly re-vegetated. There is evidence of where Other Operator (as discussed in General Comment) had commenced Reclamation activities. Per COGCC 1004 Rules; Reclamation work was to be completed within 12 months on non-crop land after Plugging of Well, which would have been 10/20/05.

Corrective Action:	<p>There are two CAs in this Section:</p> <p>1) Perform Final Reclamation per COGCC 1004 Rules including re-contouring, seeding of site and access road.
