Comment Musk thistles and Canada thistle infestations are present within the outer reclamation areas and access road. Little desirable vegetation observed within the interim reclamation areas.

Corrective Action Control weeds no later than August 27, 2019. Musk thistle flowerheads need to be cut, bagged, and properly disposed of to prevent seed dispersal. Revegetatoin needs to be conducted within the interim reclamaion areas within the fall seeding window and no later than November 1, 2019.
