**General Comment:**

On Tuesday 8/13/2019 at approximately 12:00, I, Inspector Emily Waldron, conducted a field inspection at Sandridge Exploration and Production LLC Grizzly 3-32H, at 436007 in Jackson County Colorado.  
During this inspection the following possible compliance issues were observed:  
Equipment staging in interim reclamation area. See photos 7-9. Comply with Rule 603.f, and comply with the 1003 interim reclamation rules by 9/13/2019.  
Non reportable spill - stained soil and free product at wellhead. See photos 1-4. Properly treat or dispose of oily waste in accordance with 907.e, control and contain spills/releases and clean up per Rule 906.a, and comply with Rule 603.f by 8/15/2019.  
Trash and debris on location. See photos 5-6. Comply with Rule 603.f by 8/23/2019.  
Tracking pad not adequately maintained to prevent track of material offsite. See photos 10-12. Maintain vehicle tracking BMPs on the oil and gas location to comply with rule 1002.f.(2)F. If material is tracked onto County or public roads, contact the appropriate authority by 8/23/2019.  
I spoke with Russel Shipley and Spence Laird of Sandridge on 8/14/2019 to discuss addition of tracking measures and to explain that more measures will be needed to return to compliance.  
A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
