Comment: Final Reclamation was installed at location in Fall of 2018. Vegetation has not established on berm (dam) area. Grasses are establishing in other areas of site, but are slowly being inundated and may be overwhelmed by heavy sediment flow from erosion off and on site. In Southwest corner, erosion blanket installed in two strips appears to have controlled erosion and sediment movement in this small segment; which may be indicating solution to sediment & erosion concerns at site.
