The unit boundary is the Colorado state line, which is 149' FNL Section 24 in the immediate vicinity of the BHL of this well.

This well has a bottom-hole location (BHL) beyond the 150' unit boundary setback. The BHL is only 90' from the unit boundary at 239' FNL and 1441' FWL Section 24. The bottom of the completed interval will be at the unit boundary setback of 150' at 299' FNL and 1441' FWL Section 24. The wellbore beyond the unit boundary setback will be physically isolated and will not be completed.

The distance from completed portion of proposed wellbore to nearest completed portion of offset wellbore permitted or completed within the unit was measured to the Fox Creek 12-63-25-24-1N, this distance was measured in 2D.
