**General Comment:**

On 8/12/2019, Reclamation Specialist Trujillo conducted a final reclamation and stormwater inspection at Mountain Petroleum Corp's Fitch 1-19 location in Yuma County, Colorado.

This inspection is in response to Sundry document #402040591 submitted by Operator on 5/10/2019 stating final reclamation complete, site ready for inspection.

It was documented that the location does not meet reclamation requirements; well location remains predominantly bare and exposed soil, insufficient crop establishment occurring. Issues appear to exist that is hindering reclamation.
