INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A partially buried produced water vessel (PWV) was removed from the Barclay 29C-27HZ location on July 24, 2019. Groundwater and impacted soil were not encountered in the PWV excavation. A liner was present beneath the PWV at this site; therefore, a base soil sample was not collected. The PWV at this facility has been permanently removed; the other PWV and equipment onsite will remain. Soil samples from the excavation were submitted for laboratory analysis to determine if a release occurred. The general site layout, soil sample locations, and PWV excavation dimensions are depicted on the Excavation Site Map provided as Figure 1.

Proposed Soil Sampling

On July 24, 2019, following removal of the PWV, soil samples were collected from the sidewalls of the excavation. The liner was exposed at the base of the excavation; therefore, a base soil sample was not collected. The soil samples were field-screened for volatile organic compounds using a photoionization detector. Soil samples N01@5', E01@5', S01@5', and W01@5' were submitted for laboratory analysis of benzene, toluene, ethylbenzene, and total xylenes (BTEX), total petroleum hydrocarbons (TPH), and naphthalene. Soil sample N01@5' was also analyzed for pH, specific conductance (EC), and sodium adsorption ratio (SAR). Laboratory analytical results for all soil samples indicate that BTEX, TPH, pH, EC, and SAR concentrations and levels were in full compliance with COGCC Table 910-1 allowable levels. The soil sample analytical results are summarized in Table 1, and the laboratory analytical report is attached.

Laboratory results indicate that all soil samples were in full compliance with COGCC Table 910-1 allowable levels; therefore, no soils were removed. The excavation area was backfilled and contoured to match pre-existing site conditions.

Laboratory results indicate that all soil sample concentrations and levels were in compliance with COGCC allowable levels. Groundwater was not encountered in the PWV excavation. Based on the analytical data presented herein, assessment is complete at this site and no further activities are required. This supplemental Form 27 has been prepared to request a No Further Action (NFA) determination for this site.
