Trash: Rule 603 f Corrective action date 9-4-19 See photo 3

Guy line anchors: Rule 1003.a Corrective action date 9-11-19 See photos 4,5

Produced water tank volume: Rule 210 d Corrective action date 9-21-19 See photo 8

At time of inspection I observed a duck pond blowing around location. Dead men are not properly marked.

Weather conditions: Clear and location dry

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
