<p>COGCC Inspection Report Summary</p> <p>On Monday August 26 2019 at approximately 2:59 PM, I, Inspector Randy Silver, conducted an on-site inspection at a KP Kauffman site Nessu #15, at API# 05-123-07822 in Weld County Colorado.</p> <p>While there, I observed Production well site.</p> <p>During this inspection the following possible compliance issues were observed:</p> <p>Well head sign: Rule 210 e Correction date of 7-24-19 See photo #2</p> <p>This is follow up inspection to Doc#693500491 and new complaint. At time of inspection it appears stained soil has been addressed, well was not running at time of inspection so I could not see if saddle bearing had been addressed. Pumping jack is not able to operate due to PU belts appear to be torn off and laying on ground. New well head sign had not been installed at time of inspection, old operator still on original sign.</p> <p>I spoke with complainant/landowners, Brittney White and Julie Hladky who stated gates to the entrance to the well site had been left open and their horses got out into open pasture. A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.</p> <p>This is a summary of inspection report.</p>	silverr	08/26/2019
