On Monday, August 26, 2019 at approximately 14:00, I, Inspector Brittani Santistevan, conducted an on-site inspection at CAVANAGH 36-10H6 (Noble Energy), at API #: 05-123-18232 in WELD COUNTY Colorado.

While there, I observed a cut and capped wellhead.

During this inspection the following possible compliance issues were observed:

1. Unused gas meter house still on location. All other production equipment has been removed from tank battery. COMPLY WITH RULE 603.F. (Corrective Action Date: November 26, 2019) See attached photo #3.

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
