The purpose of this Form 27 is to inform you of upcoming groundwater remediation activities planned to commence during the week of September 1, 2019. The Geoprobe investigation, well installation, and quarterly groundwater sampling activities that have occurred at the Site since 4Q2018 will be addressed in a subsequent Form 27 to be submitted prior to 4Q2019 ground water sampling activities.

Approximately 3.5" of free product has consistently been encountered in monitoring well MW-1. See attached Figure 3 and Table 2. To address the free product, Great Western plans to install a solar-powered SVE/bubbler unit at MW-1 during the week of September 1st. The unit will operate 24/7 for up to 8 months or until free product thickness has been reduced to less than 0.02 feet.
