Environmental inspection related to nearby Complaint #200448016. There is a partially buried oil skim pit and a tinhorn (culvert) associated with Pit Facility ID 112069. Active Rem #9288 should be closed with a new eForm 27 describing the tinhorn closure plan. It is likely that the partially buried oil skim tank would need to be removed in order to facilitate closure of the tinhorn and it can be included in the same Form 27.
