Core samples were obtained using a skid steer with an auger attachment, in an attempt to obtain proper documentation for pit closure. One sample was taken, as sensory observations during sampling indicated that an exceedance was probable and the sample most likely wouldn't meet Table 910-1 requirements. Analysis (attached) shows that the sample did not meet requirements for total TPH. Background (offsite) samples were not collected, as it's been previously established that high levels of arsenic are naturally occurring in the area. See attachments for previously tested high levels of arsenic in the Powder Wash area. Please see the attachments for GPS coordinates of sample and soil observations made during sampling.

	The operator shall comply with Rule 910.b.3. The operator shall ensure that analytical laboratories use appropriate methods with detection limits less than or equal to the concentrations in Table 910-1.
	The Operator shall providing a minimum of 72 hours notice to Environmental staff Kris Neidel (kris.neidel@state.co.us) or 970-871-1963 prior to conducting field operations.
	Samples shall be analyzed for the complete Table 910-1 constituent list. The Operator may request a revised constituent list if they are able to demonstrate and provide justification for a reduced list.
	From Conversation with Wexpro Staff, April Stegall, the direct push rig will have the ability to drill deeper than 20 feet if necessary to define the vertical extent.. The Operator shall assess the nature and extent of contamination with confirmation soil samples and delineate the horizontal and vertical extent of contamination. If impacts exceed 20 feet in depth then the vertical extent shall be determined.
	This Site Investigation and Remediation Workplan (Form 27) is conditionally approved; however, additional information or activities may be required during the course of remediation.
	COGCC EPS staff should be notified immediately, in the event that groundwater is encountered during investigation.
	It may be necessary to step out from the proposed 4 borehole locations around the pit to determine the lateral extent of contamination.
	The sample that is collected from the "interval indicating the highest PID reading" should be analyzed for full COGCC table 910-1.
