This is a follow-up final reclamation, good housekeeping and stormwater inspection.

This inspection is to document compliance for the following corrective actions:

603.f: Noxious weed management.

1004.a: Final Reclamation

This inspection is also in response to Form 18 complaint #200447500 in regards to noxious weed management on Foundation locations; On 6/25/2019 complainant submitted a formal complaint Form 18 regarding noxious weed issues on location #447525, and #331849 (associated with battery #447523). Complaint was forwarded to inspector on 6/26/2019 and inspector made contact with complainant on 6/27/2019 at ~08:49 hours. Complainant stated that Foundation has failed to conduct sufficient and ongoing noxious weed monitoring and management, as Diffuse Knapweed (Centaurea diffusa) has continued to establish on the locations, and spread onto the adjacent lands. Complainant also indicated that Field Bindweed (Convolvulus arvensis) has become an issue.

On 7/1/2019 and 8/8/2019, Inspector conducted a follow-up inspection, it was documented that Centaurea diffusa and Convolvulus arvensis issues remain and that sufficient and ongoing noxious weed monitoring and management does not appear to be being conducted. It was also documented that no reclamation has been conducted in accordance with 1004.a and corrective actions.

Comment:

Previous inspections documented that Diffuse Knapweed (*Centaurea diffusa*) has continued to establish on the location and spread onto adjacent lands. Inspection required operator to properly remove and control noxious weeds on location and adjacent lands.

Diffuse Knapweed remains evident on the location and the adjacent lands where weeds have spread from the Foundation location. Corrective action requiring ongoing weed management, and for operator to remove and control noxious weeds on location and adjacent lands remains applicable. Field Bindweed (*Convolvulus arvensis*) has also continued to establish and spread throughout a large portion of the location.

Corrective Action:

Properly remove and control noxious weeds on location. Properly manage and remove noxious weeds from the adjacent lands that have encroached from Foundations location. Ongoing weed management and monitoring is required, and needs to occur in accordance to COGCC rules and regulations.

<p>The following comment is copied from inspection #682503486, please see FIR for additional details:</p> <p>Complainant contacted Reclamation staff on 6/12/2018 in regards to noxious weed concerns on Foundation Locations and submitted complaint doc. #200445970 stating that "Diffuse Knapweed has returned to both locations" on 6/13/2018. The locations in reference are the Krager TB / well location and the SOONER SE SEC 21 TB location, both of which have past complaints regarding noxious weed concerns (see inspection #682401201 and inspection #682401240).</p> <p>On 6/13/2018 at 15:09, upon receiving a formal complaint, Reclamation Specialist Trujillo contacted complainant via phone to discuss concerns. Complainant stated that operator has failed to perform weed management, and weeds (Diffuse Knapweed) has continued to grow and spread from the location onto their property</p>	trujilloam	09/10/2019
