COGCC Environmental Inspection. Follow-up to 7/29/2019 Field Inspection Report (FIR) #698100051. Weather conditions during inspection were Sunny with a temperature of 65 degrees Fahrenheit.

Several corrective actions listed on previous FIR have been addressed by operator: tank battery secondary containment has been cleaned up, well cellars have been backfilled to prevent wildlife access, localized accumulations of oil-stained soil inside of fenced wellhead area have been addressed, no audible gas leaks were observed at separators or wellheads.
