While there, I observed a shut in location.  During this inspection the following possible compliance issues were observed:</p> <ol style="list-style-type: none"> <li>1. All signs on location reflect a different operator. <b>INSTALL SIGN TO COMPLY WITH RULE 210.E. (Corrective Action Date: October 9, 2019) See attached photo #1, 3.</b></li> <li>2.
