Comment: A diversion ditch created along the road has filled in with sediment, no BMP's installed up the road to prevent erosion. The disturbance of the diversion ditch needs to be seeded and stabilized. Rock check dams were improperly installed since the previous inspection and have since failed. Erosion is occurring along the side of the road. Corrective actions of previous inspection were not properly performed. See Attached Photos
