Comment: COGCC staff observed a 45 feet by 45 feet by 3 feet deep excavation where the tank battery was located (northwest side of the pad, see photos). At time of inspection, Operator was on location delineating the spill with a PID while a mini excavator removed the impacted material. Operator indicated that the impacted material was being hauled off and that the stockpiled soil on location is clean and will be used backfilling the excavation. Operator discovered additional impacted soil around a flowline riser to the north of the tank battery. Operator shall comply with COAs on Doc# 402167798.
