If evidence of fluid migration or pressure remains, contact COGCC Engineer for an update to plugging orders.</p> <p>3) Properly abandon flowlines per Rule 1105. Attach flowline abandonment job summary detailing compliance with Rule 1105.c when filing Form 6 SRA. File electronic Form 42 once abandonment of on-location flowlines is complete. Within 30 days of an operator completing abandonment requirements for an off-location flowline or crude oil transfer line the operator must submit a Flowline Report, Form 44.</p> <p>4) With the Form 6 SRA operator must provide written documentation which positively affirms each COA has been addressed.</p> <p>5) After placing the shallowest hydrocarbon isolating plug (3100'), operator must wait a sufficient time to confirm static conditions. If at any time after placing this plug there is evidence of pressure or of fluid migration, contact COGCC engineering before continuing operations.</p>
	Operator shall implement measures to control venting, to protect health and safety, and to ensure that vapors and odors from well plugging operations do not constitute a nuisance or hazard to public welfare.
