Comment:

This location is not in compliance with Rule 1004.a. Reclamation rules require reclamation activities to be conducted within three months of plugging on cropland. Well was plugged 12/19/2018. Operator has failed to perform Final Reclamation activities at the well location, as there is no apparent vegetative growth which also has not been properly contoured. This PA well location is outside of the Hester Farms II 31-H Pad disturbance area. Also, Operator has failed to remove unused equipment (safety fencing) from the well location. Refer to the attached inspection photos.

Corrective Action:

Comply with Rule 1004. Corrective action date is being back-dated to when all final reclamation work should have been completed.
