While there, I observed Wellsite.

During this inspection the following possible compliance issues were observed:

Stained soil: Rule 907.e this Compliance issue is delinquent per Doc. # 688402086 CA date 6/2/2019 See photo #3

Debris/weeds: Rule 603.f Has been partially addressed (dead weeds removed from PU and around Electric panel) it appears that the dead weeds around location have not been addressed creating compliance issue to be delinquent CA date 5/16/2019 See attached photos #2, 4, 5 and 6.

Location is dry, weather is clear.

A follow up on this site inspection needs to be conducted to ensure the Compliance issues have been corrected to comply with COGCC rules.
